A RESOLUTION RATIFYING/CONFIRMING THE CONTRACT ENTERED INTO BY THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH DEMAR CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF COVERED COURT LOCATED AT CAMELLA HOMES 3, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF P3,744,441.00 TAKEN FROM THE INFRASTRUCTURE PROJECTS UNDER THE EXECUTIVE BUDGET 2005.

WHEREAS, *Republic Act No. 9184*, otherwise known as the *Government Procurement Reform Act* authorizes the *Bids and Awards Committee (BAC)* to conduct competitive bidding in the procurement of infrastructure projects among others:

WHEREAS, one of the infrastructure projects bided was the construction of the multi-purpose covered court located at *Camella Homes 3, Barangay Tunasan, Muntinlupa City*.

WHEREAS, the *Bids and Awards Committee (BAC)* has issued/posted invitation to Bid last **December 29, 2004** to **January 12, 2005**

WHEREAS, the *BAC* evaluated the Bids submitted in the Public Bidding held last **February 18, 2005** at the *Audio Visual Room, 2nd Floor, City Hall Main Building National Road, Barangay Putatan, Muntinlupa City*

WHEREAS, the public bidding was held last **February 28, 2005** at the *Audio Visual Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa City* where three (3) bidders submitted their bid.

WHEREAS, the project was awarded to **Demar Construction** being the lowest bidder for the **construction of covered court** located at *Camella Homes 3, Barangay Tunasan, Muntinlupa City*

WHEREAS, the approved agency estimate of the contract for the project is **Three Million Seven Hundred Sixty Nine Thousand Three Hundred Eighty Pesos 14/100 (P3,769,380.14)**.

WHEREAS, the BAC pursuant to the provisions of Republic Act 9184 and the legal opinion given by the Office of the City Attorney citing Section 37 paragraph 2 of Republic Act 9184. Section 37 3 Section 38, 38 1 and 38.2 of the same Act saw no need to seek authority from the City Council prior to entering into a contract;

WHEREAS, pursuant to Section 76 of RA 9184 states that **Any other law, presidential decree or issuance, executive order, letter of instruction, administrative order, proclamation, charter, rule or regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly**.

WHEREAS, however to further enhance transparency and accountability the BAC submitted the project for ratification to the City Council

WHEREAS, based on the reports and documents submitted by the BAC to the Committee on Engineering, Public Works and Infrastructure, the said project has undergone due process for procurement and contracting for infrastructure project pursuant to RA 9184;

WHEREAS, upon ocular inspection conducted by the Committee on Engineering, Public Works and Infrastructure, the said project was completed on **July 7, 2005**.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa to ratify the contract entered into by the **City Mayor Hon. Atty. Jaime R. Fresnedi** in behalf of the **City Government of Muntinlupa** with **Demar Construction** for the project construction of **covered court** located at **Camella Homes 3, Barangay Tunasan, Muntinlupa City** in the amount of **P3,744,441.00** taken from the **Infrastructure Project Funds** under the **Executive Budget 2005**.
