WHEREAS, the approved agency estimate of the contract for the project is Forty Five Million Pesos (P45,000,000,00).

WHEREAS, the BAC pursuant to the provisions of Republic Act 9184 and the legal opinion given by the Office of the City Attorney citing Section 37 paragraph 2 of Republic Act 9184. Section 37.3. Section 38, 38.1 and 38,2 of the same Act saw no need to seek authority from the City Council prior to entering into a contract.

WHEREAS, pursuant to Section 76 of RA 9184 states that Any other law, presidential decree or issuance, executive order, letter of instruction, administrative order, proclamation, charter, rule or regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly:

WHEREAS, however to further enhance transparency and accountability the BAC submitted the project for ratification to the City Council.

WHEREAS, based on the reports and documents submitted by the BAC to the Committee on Engineering. Public Works and Infrastructure, the said project has undergone due process for procurement and contracting for infrastructure project pursuant to RA 9184.

WHEREAS, upon ocular inspection conducted by the Committee on Engineering, Public Works and Infrastructure, the said project is still on-going.

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa to ratify the contract entered into by the City Mayor Hon. Atty. Jaime R. Fresnedi in behalf of the City Government of Muntinlupa with D.L. Cervantes for the project construction of Technical School located at San Guillermo St., Barangay Tunasan, Muntinlupa City in the amount of P44,989,922.00 taken from the Infrastructure Project Funds under the Executive Budget 2005
