WHEREAS, Republic Act No. 9184. otherwise known as the Government Procurement Reform Act authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others:

WHEREAS, one of the infrastructure projects bided was the construction of covered court located at *Morning Breeze, Barangay Alabang, Muntinlupa City:*

WHEREAS, the approved agency estimate of the contract for the project is Four Million Thirty One Thousand Eight Hundred Three Pesos and 72/100 (P4,031,803.72):

WHEREAS, the BAC pursuant to the provisions of Republic Act 9184 and the legal opinion given by the Office of the City Attorney citing Section 37 paragraph 2 of Republic Act 9184. Section 37.3. Section 38, 38.1 and 38.2 of the same Act saw no need to seek authority from the City Council prior to entering into a contract:

WHEREAS, pursuant to Section 76 of RA 9184 states that "Any other law, presidential decree or issuance, executive order, letter of instruction, administrative order, proclamation, charter, rule or regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, however, to further enhance transparency and accountability the BAC submitted the contract for ratification to the City Council:

WHEREAS, based on the reports and documents submitted by the BAC to the Committee on Engineering, Public Works and Infrastructure, the said project has undergone due process for procurement and contracting for infrastructure project pursuant to RA 9184;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED. by the Sangguniang Panlungsod of Muntinlupa to ratify the contract entered into by the City Mayor Hon. Atty. Jaime R. Fresnedi in behalf of the City Government of Muntinlupa with PDJ Integcon for the project construction of covered court located at Morning Breeze, Barangay Alabang, Muntinlupa City in the amount of P4,031,803.72 taken from the Infrastructure Project Funds under the Executive Budget 2005.
