WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others;

WHEREAS, one of the infrastructure projects bided was the construction of the drainage and alley concreting located at Kappi Village, Barangay Poblacion, Muntinlupa City;

WHEREAS, the Bids and Awards Committee (BAC) has issued/posted invitation to Bid last May 04, 2005;

WHEREAS, the BAC evaluated the Bids submitted in the Public Bidding held last May 31, 2005 at the Audio Visual Room, 2nd Floor, City Hall Main Building National Road, Barangay Putatan, Muntinlupa City;

WHEREAS, the public bidding was held last May 31, 2005 at the Audio Visual Room, 2<sup>nd</sup> Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa City where two (2) of the pre-qualified bidders submitted their bid;

WHEREAS, the project was awarded to AP Melendrez Construction being the lowest bidder for the construction of drainage and alley concreting located at Kappi Village, Barangay Poblacion, Muntinlupa City;

**WHEREAS**, the *approved agency estimate* of the contract for the project is **P785,674.15**;

WHEREAS, the Bids and Awards Committee (BAC) pursuant to the provisions of *Republic Act* 9184 and the legal opinion given by the *Office of the City Attorney* citing *Section 37 paragraph 2 of Republic Act* 9184, *Section 37.3*, *Section 38, 38.1* and 38.2 of the same *Act* saw no need to seek authority from the *City Council* prior to entering into a contract;

WHEREAS, pursuant to Section 76 of RA 9184 states that "Any other law, presidential decree or issuance, executive order, letter of instruction, administrative order, proclamation, charter, rule or regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

**WHEREAS,** however, to further enhance transparency and accountability the *BAC* submitted the contract for ratification to the *City Council*;

**WHEREAS**, based on the reports and documents submitted by the *BAC* to the *Committee on Engineering, Public Works and Infrastructure*, the said project has undergone due process for procurement and contracting for infrastructure project pursuant to *RA 9184*;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa, ratifying/confirming the contract entered into by the City Mayor Hon. Atty. Jaime R. Fresnedi in behalf of the City Government of Muntinlupa with AP Melendrez Construction for the project construction of drainage and alley concreting located at Kappi Village, Barangay Poblacion, Muntinlupa City in the amount of P781,504.68 to be taken from the Infrastructure Projects under the 2005 Executive Budget.
