WHEREAS, it is the policy of the City Government of Muntinlupa to come up with a "**Coffee Table Book**" in the English language that shall contain its vision and mission as well as its economic and social progress and its cultural and historical background not only for the local consumption but also for its international audience;

WHEREAS, the title of the project is **New English Cultural, Historical and Policy Book** for the City Government of Muntinlupa;

WHEREAS, **Professor Bernard Leo Karganilla** of the University of the Philippines-Manila (UP) represents that he possess the qualifications and experience to undertake the New English Cultural, Historical and Policy Book for the City Government of Muntinlupa;

WHEREAS, the publication of the book shall include research and extension activities: provision of guidance, lectures and writings for the public executives of Muntinlupa who shall participate successfully in the preparation of the New English Cultural, Historical and Policy Book for the City Government of Muntinlupa;

WHEREAS, the objective of New English Cultural, Historical and Policy Book for the City Government of Muntinlupa is to equip the selected public executives of Muntinlupa with the guidance and other support for the preparation of the said Policy Book, and to craft the camera-ready manuscript of book for the City Government of Muntinlupa;

WHEREAS, the City Government of Muntinlupa shall grant the amount of **Two Million Pesos (P2,000,000.00)** to the project leader, to be disbursed in tranches, as follows:

- a. **Fifty percent (50%)** of total compensation as down payment before the start of the project;
- b. **Twenty-five percent (25%)** of total compensation upon completion of the series of lectures and presentations;
- c. **Twenty-five percent (25%)** of total compensation upon submission of the final report;

WHEREAS, the duration of the project shall be for one (1) year and four (4) months from **August 2005 to December 2006**;

WHEREAS, substantive changes in the project shall be made in writing and shall take effect only upon mutual approval of the two parties;

WHEREAS, for the expected output, the project leader shall run the New English, Cultural, Historical and Policy Book for the City Government of Muntinlupa, shall provide the project with competent writers and other publication professionals;

WHEREAS, the City Government of Muntinlupa shall provide the venue and the facilities for all sessions of the project, and shall ensure the religious attendance and cooperation of the selected participants in the project, including the evaluation of the project upon its completion;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod authorizing the **City Mayor Hon. Atty. Jaime R. Fresnedi** to enter into a **Memorandum of Agreement (MOA)** with **Professor Benard Leo Karganilla** regarding the preparation of the **New English Cultural, Historical and Policy Book** for the City Government of Muntinlupa in the total amount of **Two Million Pesos (P2,000,000.00)**.
