A RESOLUTION GRANTING THE REQUEST OF REN TRANSPORT A TEN PERCENT (10%) INCREASE IN THE MONTHLY PAYMENT FOR THE GARBAGE COLLECTION, HAULING AND DISPOSAL SERVICES OF REN TRANSPORT CORPORATION FROM SIX MILLION EIGHT HUNDRED THREE THOUSAND FIVE HUNDRED TWENTY NINE PESOS AND 06/100 (6,803,529.06) TO SEVEN MILLION FOUR HUNDRED EIGHTY-THREE THOUSAND EIGHT HUNDRED ONE PESOS AND 97/100 (PHP7,483,801.97) TO BE TAKEN FROM THE 2005 EXECUTIVE BUDGET.

WHEREAS, there is a need to achieve the objectives of managing a comprehensive solid waste management system in the City of Muntinlupa;

WHEREAS, the City Government last granted an increase of **five percent (5%)** in the contract price in **Resolution No. 04-063** approved by the 4th Sangguniang Panlungsod last **December 29, 2004**.

WHEREAS, the **REN Transport Corporation** requested the City Government of Muntinlupa a **thirty percent (30%) increase** in the monthly payment for the collection and hauling of garbage due to the rapid increase of cost of fuel and maintenance expenses

WHEREAS, after reviewing the request of the contractor the Local Finance Committee recommended a **ten percent (10%) increase** in the monthly payment.

WHEREAS, the approved **ten percent (10%) increase** will commence October 1, 2005.

WHEREAS, there is a budget allocated for the said increase from the **2005 Executive Budget**



NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa, granting the request of **REN Transport** a **ten percent (10%) increase** in the monthly payment for the garbage collection, hauling and disposal services of **REN Transport Corporation** from **Six Million Eight Hundred Three Thousand Five Hundred Twenty Nine Pesos and 06/100 (Php6,803,529.06)** to **Seven Million Four Hundred Eighty-Three Thousand Eight Hundred One Pesos and 97/100 (Php7,483,801.97)** to be taken from the **2005 Executive Budget**.
