WHEREAS, N.C. TAVU & Associates Corporation (the "Project Proponent") submitted to the City Government of Muntinlupa an "unsolicited proposal" to build, operate and transfer elevated multi-link pedestrian crossings (with a commercial component) at the intersection of the South Luzon Expressway ("SLEX"), Alabang-Zapote Road and Montillano Road, specifically underneath the so-called Alabang Viaduct (the "Site"), that will enable pedestrians to cross the intersection without using, or minimizing to a large extent the use of the street level, and in the process assure the safety of pedestrians and decongest traffic of vehicles plying said intersection. Said elevated multi-link pedestrian crossings shall have stalls or spaces to be leased out by the Project Proponent to interested persons, and enable it to recover its investment and earn a reasonable return thereon;

WHEREAS, the City Government's Bids and Awards Committee (BAC) and the Hon. City Mayor Atty. Jaime R. Fresnedi had, in its Memorandum dated 19 December, 2005 addressed to the Sangguniang Panlungsod, determined that the said "unsolicited proposal" is being submitted by the Project Proponent in accordance with the provisions of Rep. Act No. 6957, as amended by Rep. Act No. 7718, and its implementing rules and regulations, and is an infrastructure project that will be funded by the Project Proponent and will benefit the people of Muntinlupa; and

Fresnedi recommended that the Sanggunian: 1. approve to consider the proposal submitted by the Project Proponent as an "unsolicited proposal" under the provisions of Rep. Act No. 6957, as amended by Rep. Act No. 7718, and in its implementing rules and regulation; 2. approve to pre-qualify the Project Proponent; 3. grant the Project Proponent "original proponent status"; 4. authorize the Hon. Mayor Jaime R. Fresnedi through the BAC to negotiate and finalize the terms and conditions of the proposed contract, at such terms and conditions he may deem advantageous to the City Government, covering the implementation of the Project for purposes of coming out with terms of reference for comparative bidding, including finalizing the tender documents relative to such bidding in accordance with the provisions of Rep. Act No. 6957, as amended by Rep. Act No. 7718, and its implementing rules and regulations; and 4. direct the BAC through the Honorable Mayor Jaime R. Fresnedi to submit the results of the comparative bidding and its recommendations to the Sanggunian;
