**WHEREAS**, Rule XVII, Article 99 (5) (vii) of Republic Act 7160, otherwise known as the Local Government Code of 1991 Implementing Rules and Regulation, provides that, *"the Sanggunian as the legislative body of the City shall approve resolutions and enact ordinances which shall ensure the efficient and effective delivery of the basic services and facilities xxx shall establish and provide for the maintenance, repair and operation of an efficient waterworks system to supply water and to purify the source of water supply"*:

**WHEREAS**, the City of Muntinlupa has a total of population of 379,310 based on the 2000 data that was submitted by the National Statistic Office (NSO);

**WHEREAS**, the City Planning Office has a projected population of 462,029 for the year 2006;

**WHEREAS**, the Metropolitan Water Works Sewerage System (MWSS) through Maynilad Water Services, Inc., which covers the West Zone of Metro Manila had started implementing their projects in the City of Muntinlupa during the year 2003 rendering water services to the following areas in different barangays, namely:

- BLISS Housing, Putatan;
- Buendia St., Tunasan;
- Arandia St., Tunasan;
- JPA Subdivision, Tunasan;


**BE IT RESOLVED FURTHER**, that a public hearing must be conducted wherein officials of the MWSS and Maynilad shall be invited;
