WHEREAS, the contract of REN Transport Corp. for the garbage collection, hauling and disposal services in the City of Muntinlupa will expire on February 28, 2006;

WHEREAS, the Sangguniang Panlungsod earlier passed Resolution No. 05-101 (Resolution authorizing the Hon. City Mayor Atty. Jaime R. Fresnedi to enter into a new contract in behalf of the City Government of Muntinlupa with REN Transport Corp. in garbage collection and disposal services from June 1, 2005 to February 2006 in the amount of P61,231,761.62);

WHEREAS, in the exigency of public service and so as not to disrupt the continued collection and disposal of garbage in the City of Muntinlupa there is an imperative need to extend the contract for another six months to avoid a garbage crisis which may seriously affect the good health of the people, pending the public bidding to be conducted by the Bids and Awards Committee (BAC);


WHEREAS, extension of this contract will commence on March 1, 2006 and will expire on August 31, 2006:
