WHEREAS, there is a need to number consecutively each and every line of the journal of the Sangguniang Panlungsod to facilitate corrections thereof;

WHEREAS, the new paragraph shall be inserted after the third paragraph of Section 77 which reads as follows, *"The journal of every session shall be read, corrected and approved by a majority of the Members present at the session. The reading of the journal shall not be interrupted or suspended except by unanimous consent of the Body."*;

WHEREAS, Rule XII, Section 77, of Internal Rules of Procedures, shall be amended by means of inserting a new paragraph and it will read as follows:

"The contents of the journal shall be numbered consecutively on its left margin, beginning from the title of the first page and every line thereafter in every page thereof, and ending in the certification by the Secretary to the Sangguniang Panlungsod of the said journal."

The numbering shall be done to facilitate corrections of the journal of the previous session, whether regular or special".

NOW THEREFORE, BE IT RESOVED AS IT IS HEREBY RESOLVED, by the Fourth Sangguniang Panlungsod amending Rule XII, Section 77, of Internal Rules of Procedure of the Fourth Sangguniang Panlungsod by inserting a new paragraph thereof.




