RESOLUTION NO. 06-220

A RESOLUTION TEMPORARILY SUSPENDING THE IMPLEMENTATION OF ORDINANCE NO. 04-011, "AN ORDINANCE REQUIRING OWNERS OF BANKS DOING BUSINESS WITHIN THE CITY OF MUNTINLUPA TO PROVIDE AN ALARM SYSTEM ATTACHED TO OR CONNECTED WITH THE NEAREST PHILIPPINE NATIONAL POLICE STATION AND TO HAVE A CLOSE CIRCUIT TELEVISION MONITORING SYSTEM, AND PROVIDING THEREWITH". NON-COMPLIANCE FOR FOR PENALTY EXTENDIBLE PERIOD OF NINETY (90) DAYS FROM APPROVAL HEREOF.

WHEREAS, on October 4, 2004, the Sangguniang Panlungsod passed Ordinance 04-011, "An Ordinance requiring owners of banks doing business within the City of Muntinlupa to provide an alarm system attached to or connected with the nearest Philippine National Police Station and to have a Close Circuit Television Monitoring System, and providing penalty for noncompliance therewith";

WHEREAS, Section 3 of said Ordinance provides that "Bank owners with existing branches presently operating in the City of Muntinlupa shall be given until January 2005 to comply with this Ordinance. New branches that may be put up beyond January 2005 shall first submit a written compliance from the Muntinlupa Philippine National Police before applying for a new business permit;

WHEREAS, on January 6, 2006, the Federation of Metro Manila Rural Banks, Inc., through its President, Benjamin C. Avelaga, sent a letter to City Mayor Atty. Jaime R. Fresnedi, requesting that Rural Banks operating in Muntinlupa City be given sufficient time of at least three (3) months to comply with the abovecited Ordinance, for the following reasons:

a Some of its members have not received the letters sent for this purpose or received them just recently;

b. Procurement and installation of said security facilities will entail longer

period; and
