WHEREAS, the City of Muntinlupa, through the Honorable Mayor Jaime R. Fresnedi, entered into a Memorandum of Agreement (MOA) with the Ospital ng Muntinlupa Foundation, Inc. for the operation and management of the Ospital ng Muntinlupa;

WHEREAS, the contract of Ospital ng Muntinlupa Foundation, Inc. shall expire on 31 March 2006, without any agreement for renewal or extension;

WHEREAS, beginning 01 April 2006, the City of Muntinlupa shall assume the operation of and management of the Ospital ng Muntinlupa from the Ospital ng Muntinlupa Foundation, Inc., through an Oversight Committee created under Executive Order No. 03 series of 2006 dated March 09, 2006;

WHEREAS, in connection with and as a lawful incident of the operations of the Ospital ng Muntinlupa, there will be collected and imposed reasonable hospital fees and charges, as prescribed by the Sangguniang Panlungsod;

WHEREAS, pursuant to existing government accounting and auditing rules and procedures, a Special Account under the General Fund of the City Government needs to be created and maintained for the Ospital ng Muntinlupa, at the same time that all hospital fees and charges to be collected and all monies accruing to or to be received by the hospital should be deposited in a separate bank account in the name of the City Government of Muntinlupa, from and against which all expenses relative to the operation, management, development and improvement of the hospital shall be drawn;

WHEREAS, all disbursements under this separate special account shall follow the usual auditing rules and procedures;
