WHEREAS, the *Ospital ng Muntinlupa Foundation, Inc.* has for its vision the achievement of a viable Hospital Care System, providing accessible, affordable, total quality health service to people in need with preference to bonafide residents of Muntinlupa City, especially the marginalized members of its constituency;

WHEREAS, the *Foundation's* objectives are to ensure that the hospital health care system for the community is sound, and to instill a culture in the hospital that will be characterized by "*spirit of service*", "*sense of duty and commitment*", and "*respect for the human individual*";

WHEREAS, true to the call of the City Government, the *Foundation* was able to channel back whatever meager savings through the procurement of equipment and supplies, and has encouraged the affiliation of nursing and caregiver schools to beef up the limited nursing personnel which not only added to the manpower of the hospital but also helped in supplementing the limited equipment and supplies of the foundation.
