WHEREAS, Mr. and Mrs. Olazo requested the City Government of Muntinlupa for a 10% increase rate as stated in the previous contract which is the first time they are increasing the rental rate after a period of four (4) years:

WHEREAS, with an increase of 10% the contract of lease amounting to P16,500.00 per month will now amount to P18,150.00 per month and shall be paid every 4th day of the month;

WHEREAS, the said contract shall take effect from May 1, 2006 up to and until the completion of the MRH facility in Bayanan Bay walk;
