WHEREAS, Section 2, of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act provides that, "*it is declared policy of the state to promote the ideas of good governance in all its branches, departments, agencies, subdivisions, and instrumentalities, including government-owned and controlled corporations, and local government units*";

WHEREAS, the same act provides that each procuring entity shall establish a single bids and awards committee for its procurement needs;

WHEREAS, the Sangguniang Panlungsod is an entity separate and distinct from the Executive whose procurement requirements need to be addressed with dispatch;

WHEREAS, the proposed members of the Bids and Awards Committee in the Sangguniang Panlungsod Office shall be composed 5 regular employees whose Chairman shall elected from among the members;




