Attorney and Associate Attorney of the Ciriaco Lopez, Jr. & Associates in 1981-1983 and 1983-1984, respectively; and as Partner of the Nepomuceno Atencia & Togonon in 1984-1986;

WHEREAS, as public servant, City Prosecutor Edward M. Togonon was appointed as Pasay City Acting Asst. City Prosecutor in October 1986; Pasay City 4th Asst. City Prosecutor, in January 16, 1987; Pasay City 3rd Asst. City Prosecutor, in March 3, 1992; Pasay City 2nd Asst. City Prosecutor, in May 25, 1993, and as City Prosecutor of the City of Muntinlupa in September 2, 2000;

WHEREAS, City Prosecutor Edward M. Togonon was awarded "Award of Recognition", given by the Pasay City Lawyers Association on October 3. 1992; "Outstanding Prosecutor", given by the Pasay City Lawyers Association on February 3, 1994, by the then Secretary of Justice, now Senator Franklin Drilon during the National Prosecutors' League of the Philippines Convention in Baguio City on June 8, 1994, and by the Consumers Union of the Philippines during its 9th Annual Awards held at PICC on May 1, 1997, respectively; and a "Plaque of Appreciation", given by the Pasay Prosecutors' League on the occasion of the induction of the new set of officers of the League held on November 8, 1995;
