WHEREAS, Article 99 of Implementing Rules and Regulations of Local Government Code of 1991, provides that, "the Sangguniang Panlungsod as the Legislative Body of the city, shall enact ordinances, approved resolutions and appropriate funds for the general welfare of the city and its inhabitants";

WHEREAS, pursuant to Section 16 of the Local Government Code mandates that, "every local government until shall, among other things, promote health and safety";

WHEREAS, the City Government desires to address the problem on the supply of water by embarking on a Special Project to be known as "Free Water Delivery Program", giving priority to those residing in the depressed areas/communities without access to their own water source;

WHEREAS, Manila Water, through its MWC – Taguig Business Area, has agreed to supply the potable water needed for the said project;

WHEREAS, the Manila water, through its Manila Water –Taguig Business Area located at University Parkway Avenue Global City, Fort Bonifacio Taguig City, shall provide 20 cubic meters of potable water every 6:00 A.M. to 6:00 P.M daily which shall be placed or dispensed on approximately four (4) water delivery trucks of the city;

**WHEREAS**, the parties agree that the city shall pay Manila Water for the water that it gets from it amounting to **Sixteen Pesos (Php16.00)** per cubic meter and subject to adjustment based on the existing MWC/MWSS policy;

**WHEREAS**, the Manila Water shall bill the City its monthly water withdrawal every first (1<sup>st</sup>) week of the month for which billing must be paid by the city within ten (10) days upon receipt of statement of billing;

**WHEREAS**, Manila Water reserves to the right to discontinue the supply of water due to non-payment of billing on the prescribed period;

**WHEREAS**, the amount of **Three Hundred Twenty Pesos (Php 320.00)**, per day can be taken from the CDF since this entailed services for the constituents of the city;

**WHEREAS**, the Manila Water Company Inc., shall likewise train the City with the following services, free of charge;

1. Train the City's personnel in the proper handling of the water, to ensure that the water's potability is maintained and not jeopardized.
2. Train the city's personnel on how to properly disinfect the trucks that the city will use for this purpose.


**WHEREAS**, Article 16 of Republic Act 9184 provides that there is no need for bidding for the procurement of water in the Manila Water Company Inc. because it is allowed in the direct procurement method as one of the Alternative Methods of Procurement;




