WHEREAS, the Local Finance Committee passed Resolution No. 17 dated 7 February 2006 recommending to offer the vacant second floor portion of the New Muntinlupa Public Market located in Alabang, City of Muntinlupa to interested parties;

WHEREAS, the recommendation of the Local Finance Committee is being made to increase the income of the city, generate employment and spur economic activities in the city which will in turn be beneficial to the general welfare of the people of Muntinlupa;

WHEREAS, the recommendation is also based on the earlier recommendation of the Commission on Audit (COA) that it should be offered for lease to generate income for the city government;

WHEREAS, the offer for lease shall cover an area of four thousand square meters, more or less, under terms and conditions that will be proposed by the Local Finance Committee and the Bids and Awards Committee, subject to existing laws, rules and regulations;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor, Atty. Jaime R. Fresnedi through the Local Finance Committee and the Bids and Awards Committee (BAC) to offer for lease the vacant second floor portion of the New Muntinlupa Public Market to interested parties to increase the income of the City.




