The Sangguniang Panlungsod shall act on appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed.**";

WHEREAS, *Mr. Herminio A. dela Cruz* of the City Assessor's Office is appointed as City Government Head III by the Honorable City Mayor, Atty. Jaime R. Fresnedi;

WHEREAS, *Mr. Herminio A dela Cruz* meets the required qualifications under the Local Government Code and Qualifications Standard as set by the Civil Service Commission;

RESOLVED THEREFORE, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod to confirm the appointment of *Mr. Herminio A dela Cruz* as *City Department Head III* of the *City Assessor's Office*.
