WHEREAS, the City Government of Muntinlupa and the Government of Liuzhou, China have a common desire to promote favorable relations of partnership and cooperation between them and their constituents;

WHEREAS, in the pursuit of the said goal, the City Government of Muntinlupa and the Government of Liuzhou, China have agreed to establish the sister TV Station relationship under the "**principles of equality and mutual benefits**" as follows:

1. To promote the understanding and cooperation between the peoples of Liuzhou, China and Muntinlupa-PIO and enhance the friendship and exchanges between the People's Republic of China and Muntinlupa, Philippines through the exchange programs about TV and Radio;
2. Taking the advantage of being media organization, to share and create the programs. To introduce the history, culture, custom, landscape, economy and social development of each side through the website;
3. The TV reception quality and the content that are provided by one side should reach the requests as possible when displaying;

4. On the principle of equality, both sides can consider to carry out exchanges in the fields that both sides are interested in multi-ways, such as jointly making programs, sending journalists to collect stories and doing job shadowing. The host should provide assistance to the other party as possible;
5. Organizing the delegation to visit each other, no more than twice a year;
6. During carrying out the exchange programs, both sides should obey the laws and respect the custom of each country;
7. This Agreement is subject to Five (5) Years

WHEREAS, the City Government of Muntinlupa will be the first Local Government Unit to tie-up locally in an Asian station, a good learning experience for the City's Public Information Office in strengthening the sister city, wide dissemination of the city's program, to include our Vision 2020;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi** to sign for and in behalf of the City Government of Muntinlupa the **Memorandum of Agreement (MOA)** with the **Government of Liuzhou, China** regarding tie-up of our Local TV Program, Lingkod Bayan and TV-Liuzhou, China Daily TV, and a tie-up between Liuzhou Daily Papers-Lingkod Bayan Newsletter.
