WHEREAS, Article 99 (iv), of the Local Government Code of 1991, Implementing Rules and Regulations, provides that, the Sangguniang Panlungsod as legislative body of the city, shall approve ordinances and pass resolutions necessary for an efficient and effective city government, and relative thereto, shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance to victims during and the aftermath of said disasters or calamities and their return to productive livelihood following said events;

WHEREAS, on April 27, 2007, at Freewill Subdivision, Putatan, Muntinlupa City, a fire totally destroyed five (5) houses and partially damaged four (4) houses affected nineteen (19) families, total of seventy eight (78) persons, said fire also caused the death of twelve (12) years old boy and critically wounded an eleven (11) years old girl;;

WHEREAS, on May 12, 2007, at St. Mary St., JPA Subdivision, Tunasan, Muntinlupa City, a fire destroyed and damaged seven (7) houses, and affected seven (7) families total of twenty two (22) persons;

WHEREAS, on July 6, 2007, at Sunflower St., Extension, Patdu Compound, Putatan, Muntinlupa City fire destroyed five (5) houses and which affected twelve (12) families, total of fifty (50) persons;




