WHEREAS, Article 99 (iv), of the Local Government Code of 1991, Implementing Rules and Regulations, provides that, the Sangguniang Panlungsod as legislative body of the city, shall approve ordinances and pass resolutions necessary for an efficient and effective city government, and relative thereto, shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and the aftermath of said disasters or calamities and their return to productive livelihood following said events:

WHEREAS, on *July 22, 2007,* at *Lot 35 (Likod), Soldiers' Hills Village, Putatan, Muntinlupa City*, a fire totally damaged Eighty (80) houses, partially damaged one (1) house and injured three (3) persons with minor laceration;

WHEREAS, the Social Services Department (SSD) recommended to declare the affected area as in <u>a state of calamity</u>;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the members of the 5th Sangguniang Panlungsod, to declare the area affected by the fire on July 23, 2007, at Lot 35 (Likod) Soldiers' Hills Village Muntinlupa, as in a state of calamity.

APPROVED, by the 5th Sangguniang Panlungsod of Muntinlupa this 23rd day of July, 2007, on its 4th Regular Session.


