WHEREAS, Article 99, paragraph 2(iii), of Implementing Rules and Regulations, otherwise known as the Local Government Code of 1991, provides that, the Sangguniang Panglungsod, as the Legislative body of the city, shall enact ordinances and approve resolutions and appropriate funds for the general welfare of the city and its inhabitants xxx, **shall:**

“2(iii) subject to the provisions of Book II of the Code and upon majority vote of all the members of the Sangguniang Panlungsod, authorize the City Mayor to negotiate and contract loans and other forms of indebtedness”;

WHEREAS, the City Mayor Hon. Aldrin L. San Pedro, has requested the City Council through his letter dated August 6, 2007, to give him authority to secure or obtain a loan from any reputable banking institution in the sum of **One Billion Pesos (Php1,000,000,000.00);**

WHEREAS, said amount shall be used for the construction of a new City Hall of the City Hall Building;

San Pedro** to secure or obtain a loan with any reputable banking institution in the amount of **One Billion Pesos (Php1,000,000,000.00)** for the construction of a new city hall building of the City of Muntinlupa.






