WHEREAS, the Constitution and By-Laws of the Metro Manila (Phils.) Councilors' League, provides that, *"the Local Legislative Bodies in every City and Municipality in Metro Manila shall nominate an official representative to represent the Local Sangguniang Panlungsod/Bayan in the Executive Board of the said League"*;

WHEREAS, pursuant to the Memorandum Circular No. 2007-78, dated July 17, 2007 issued and signed by DILG Secretary Hon. Ronaldo V. Puno under paragraph 2 and 3, to wit:

*"2. Within 90 days upon assumption to office of the regularly elected members of the Sangguniang Panlungsod of highly urbanized cities and independent component cities and on the date fixed by the National Board, all Regional Chairmen, whether incumbents or interim by virtue of succession, shall convene the said Sangguniang members to a meeting to elect from among themselves the City Chapter Officers"*

**3. Within 90 days after the Provincial Federation and City Chapter Elections and on the date set by the National Board, all Regional Chairmen, whether incumbents or interim by virtue of succession shall convene all the Provincial Federation Officers and City Chapter Officers to a meeting to elect from among themselves the Regional Council Officers;**

**WHEREAS**, a follow up letter dated **August 7, 2007** signed by DILG Muntinlupa City **Director Adoracion T. Cuevas** was transmitted to the Office of the Vice-Mayor of Muntinlupa City requiring the election of Officers of the PCL City Chapter and Regional Officers, also **Hon. Atty. Raul R. Corro**, former Councilor and Majority Floor Leader of Muntinlupa City, and the incumbent Chairman of MMPCL, thru his letter dated August 21, 2007, informed our **Vice-Mayor Hon. Artemio A. Simundac**, that the League will hold the election of their officers on **August 29, 2007** at **Kap Moy Cultural House and Restaurant, Barangay Sta. Elena, Marikina City**;

**WHEREAS**, the term of office of the official representative to the Executive Board of the said League ends with the term of office of an elected Councilors;

**WHEREAS**, the former representative of Muntinlupa **Hon. Councilor Atty. Raul R. Corro** has finished his third-term as City Councilor last June 30, 2007;

**WHEREAS**, there is a need to appoint a Councilor to replace the previous representative in order to represent the Sangguniang Panlungsod of Muntinlupa in the said League;

**NOW THEREFORE, BE IT RESOLVE AS IT IS HEREBY RESOLVED**, by the 5<sup>th</sup> Sangguniang Panlungsod of Muntinlupa to appoint **Hon. Coun. Francis Ian T. Bagatsing** as official representative and **Hon. Coun. Atty. Icasiano M. Dela Rea** as official alternate representative to **METRO MANILA (PHILS.) COUNCILOR'S LEAGUE (MMPCL)** and its mother unit **Philippine Councilors' League (PCL)**.




