**WHEREAS**, Article 99, paragraph 2(iii), of Implementing Rules and Regulations, otherwise known as the Local Government Code of 1991, provides that, the Sangguniang Panglungsod, as the Legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants xxx, **shall xxx authorize the City Mayor to negotiate and contract loans and other forms of indebtedness**;

**WHEREAS**, on August 6, 2007 the 5<sup>th</sup> Sangguniang Panlungsod adopted **Resolution No. 07-008** entitled, "a resolution authorizing the City Mayor Hon. Aldrin L. San Pedro to secure or obtain a loan with any reputable banking institution in the amount of One Billion Pesos (Php1,000,000,000.00) for the construction of a new city hall building of the City of Muntinlupa";

**WHEREAS**, on September 3, 2007, City Mayor Hon. Aldrin L. San Pedro requested the City Council through his letter dated August 31, 2007, to give him authority to secure or obtain a loan from any reputable banking institution in the adjusted amount of **One Billion Five Hundred Million Pesos (Php1,500,000,000.00)** for the construction of a new City Hall of Muntinlupa at new site in Alabang and other infrastructures projects;


