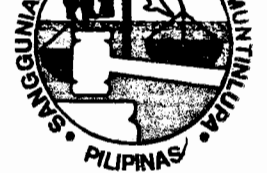

WHEREAS, on August 13, 2007 the 5th Sangguniang Panlungsod enacted Ordinance No. 07-008 and approved by the Hon. City Mayor Aldrin L. San Pedro on August 24, 2007, entitled, "an ordinance approving Supplemental Budget No. 3 in the amount of One Hundred Sixty Three Million, One Hundred Sixty Thousand One Hundred Sixty Five Pesos and 96/100 (Php163,160,165.96)"; as amended by Ordinance No. 07-010;

WHEREAS, the Technical Working Group (TWG) of the City Government of Muntinlupa set the Public Bidding on September 17, 2007 for the twelve (12) proposed projects;

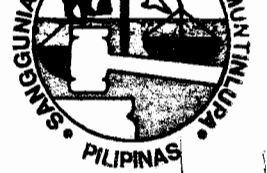


