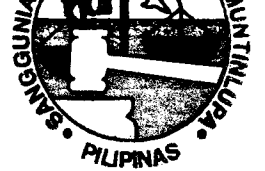

WHEREAS, on or about **6:25 o'clock** in the morning of **18 August 2007**, **SECOND LIEUTENANT JIFFREY M. LEOVERAS** 0-136279, Philippine Navy (Marines) together with Test Mission Group Class 13, Force Reconnaissance Company, Force Reconnaissance Battalion, Philippine Marine Corps, Philippine Navy were deployed to conduct surgical raid at Barangay Singkalum, Albarka, Basilan Province in Mindanao;

WHEREAS, during said mission, the group encountered with undetermined number of lawless terrorists wherein **2nd Lt. Jiffrey M. Leoveras** and his comrades were killed in action;

WHEREAS, on the date of the incident, **2ND Lt. Leoveras** was a resident of **Lot 28, Block 4, St. Dominic Street Sto. Niño Village, Barangay Tunasan, Muntinlupa City**, together with wife **Hazel L. Leoveras** and two (2) sons aged 4 and 2 years old;

WHEREAS, the **City of Muntinlupa** joins the **Nation** in *Commemorating and Honoring* the Heroism and Gallantry of **2ND LIEUTENANT JIFFREY M. LEOVERAS** who died in the performance of his duties and risking his life in fighting terrorism at Basilan Province in Mindanao;




