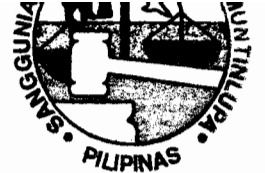
WHEREAS, in 1994 up to 2003 he acted as City Engineer and City Building Official of the City Government of Muntinlupa;


