WHEREAS, the proposed **Bill** to amend certain provisions of **Republic Act No. 7924** includes a provision to grant Legislative Power or authority to enact ordinances or resolutions to the Metropolitan Manila Development Authority (MMDA);

WHEREAS, the powers devolved to the Local Government Units (LGU) are enshrined in the Constitution of the Philippines and the Local Government Code of 1991;

WHEREAS, the proposed Bill is in conflict with the Legislative Power or authority already specifically vested in Local Government Units pursuant to Republic Act 7160 and their respective City Charters;

WHEREAS, instead of vesting MMDA with Legislative Power it should merely coordinate and closely monitor and supervise the proper implementation of ordinances enacted by the LGU's within their respective jurisdiction;

WHEREAS, the scope of powers and functions of MMDA to be enforced in Metro-Manila should only cover those which are authorized by laws, rules and regulations;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the **5th Sangguniang Panlungsod of Muntinlupa**, advocating an opposed and strong objection to the grant of legislative powers and authority to the Metro Manila Development Authority (MMDA).

RESOLVED FURTHER, by the 5th Sangguniang Panlungsod of Muntinlupa that a copy of this Resolution be furnish the *Office of the President, Metro Manila Development Authority (MMDA), Senate of the Philippines, Congress of the Philippines, Office of Congressman Rozano Rufino B.
