WHEREAS, Muntinlupa City is undergoing a very rapid transformation and development as a highly urbanized city in the National Capital Region;

WHEREAS, with the mushrooming constructions of new houses, buildings and edifices for residential, commercial and industrial purposes, the local government has not established nor updated numbering system thereof;

WHEREAS, on **September 26, 2007**, the Committee on Land Use and Zoning called a Public Hearing in aid of legislation to determine the present status of the numbering system of houses, buildings, edifices and the likes in the City. Said public hearing was well attended by representatives from **Barangays, Post Office, Engineering Department, Planning and Zoning Department and a representative from the Sangguniang Panlungsod Secretariat**;

WHEREAS, the participants in the said public hearing attested and confirmed that the present numbering of houses, buildings, edifices and the likes is in disarray and confusing that it needs to be updated using the modern system of geographical location and mapping by creating a special committee thereof;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod of Muntinlupa City, to authorize **Hon. Mayor ALDRIN L. SAN PEDRO** to create a Special Committee to study, design and formulate systematic methods of numbering of houses, buildings, edifices and the likes within the Territorial Jurisdiction of Muntinlupa City;

RESOLVED FINALLY, that the **Budget** for the said Committee will be taken from **City Executive Office** duly supported by an appropriation ordinance to be passed by the City Council.

APPROVED, by the 5th Sangguniang Panlungsod this 22nd day of **October 2007**, on its 14th Regular Session.






