A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, TO REPRESENT THE CITY GOVERNMENT OF MUNTINLUPA, TO ENTER INTO A CONSTRUCTION AGREEMENT WITH VIC VERA BUILDERS, INC. FOR THE PROJECT, IMPROVEMENT OF SIDEWALK AT THE NATIONAL ROAD FROM TUNASAN TO ALABANG, MUNTINLUPA CITY, IN THE AMOUNT OF SEVENTEEN MILLION FIVE HUNDRED THIRTY FIVE THOUSAND FIVE HUNDRED NINETY EIGHT PESOS AND 77/100 (PHP17,535,598.77) WHICH AMOUNT SHALL BE TAKEN FROM THE RE-ALIGN/SUPPLEMENTAL BUDGET NO. 3.

WHEREAS, *Republic Act No. 9184*, otherwise known as the **Government Procurement Reform Act**, authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others;

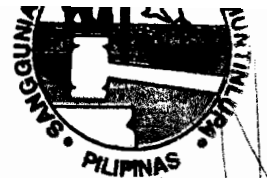
WHEREAS, on **September 3, 2007**, the Sangguniang Panlungsod approved Resolution No. 07-020, entitled, "*a resolution authorizing the City Mayor Hon. Aldrin L. San Pedro to enter into a contract with the winning bidder for each of the twelve (12) infrastructure projects pursuant to compliance with the existing laws, rules, and regulations on public bidding and submission of said contracts to the Sangguniang Panlungsod for a appropriate review and approval*";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3. Section 38.1 of the same Act, "*saw no need to seek authority from the City Council prior to entering into a contract*";

WHEREAS, pursuant to **Section 76 of RA 9184**, states that, "*any other law, presidential decree or issuance, executive order, letter of instruction, administrative order, proclamation, charter, rule or regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly*";

WHEREAS, however, to further enhance transparency and accountability the **Hon. City Mayor Aldrin L. San Pedro** submitted to the City Council the Construction Agreement for ratification;

WHEREAS, based on the reports and documents submitted by the City Mayor to the Sangguniang Panlungsod the said project has undergone due process for procurement and contracting for infrastructure project pursuant to RA 9184;

WHEREAS, the amount appropriated for the said project shall be taken from the approved Supplemental Budget No. 3, as stated in **Ordinance No. 07-008** as amended by **Ordinance No. 07-010**;

WHEREAS, the project construction of **Improvement of Sidewalk** located at National Road and shall cover areas from Tunasan to Alabang, Muntinlupa City;

WHEREAS, on **September 21, 2007**, the City Government of Muntinlupa entered into a Construction Agreement and it was notarized on **October 8, 2007** with Vic Vera Builders for the construction of the project amounting to Seventeen Million, Five Hundred Thirty Five Thousand Five Hundred Ninety Eight Pesos and 77/100 (17,535,598.77), as a result of a public bidding held on September 17, 2007;

WHEREAS, the **Approved Agency Estimate (AAE)** of the contract for the said project is Seventeen Million, Five Hundred Thirty Nine Thousand Three Hundred Eighty One Pesos 34/100 (**P17,539,381.34**);

WHEREAS, the contract implementation covers a period of 45 calendar days from the date the contractor receive the written Notice to Proceed;

WHEREAS, the Bids and Awards Committee (BAC) evaluated the Bids submitted in the public bidding held last September 17, 2007 and there were two pre-qualified bidders submitted their bid;

WHEREAS, the project was awarded to **Vic Vera Builders** who being the lowest bidder for the construction of Improvement of Sidewalk at the National Road from Tunasan to Alabang, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod of Muntinlupa to authorize the **City Mayor Hon. Aldrin L. San Pedro**, to represent the City Government of Muntinlupa, to enter into a Construction Agreement with **VIC VERA Builders, Inc.** for the project, Improvement of Sidewalk at the National Road, from Tunasan to Alabang, Muntinlupa City, in the amount of Seventeen Million Five Hundred Thirty Five Thousand Five Hundred Ninety Eight Pesos and 77/100 (Php17,535,598.77).

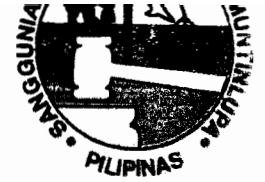
