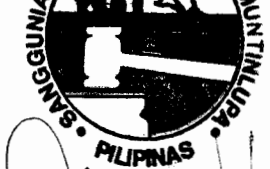

RESOLUTION NO. 07-049

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, TO REPRESENT THE CITY GOVERNMENT OF MUNTINLUPA, TO ENTER INTO A CONSTRUCTION AGREEMENT WITH SOCOR CONSTRUCTION, CORPORATION FOR THE PROJECT, ASPHALT OVERLAY & CONCRETE BLOCKING OF NATIONAL ROAD FROM ALABANG TO TUNASAN-SAN PEDRO BOUNDARY, MUNTINLUPA CITY, IN THE AMOUNT OF ONE HUNDRED TWENTY NINE MILLION NINE HUNDRED FIFTY FOUR THOUSAND FOUR HUNDRED FIFTY NINE PESOS AND 76/100 (PHP129,954,459.76) WHICH AMOUNT SHALL BE TAKEN FROM THE APPROVED ONE BILLION FIVE HUNDRED MILLION PESOS STAND-BY LOAN AS STATED IN RESOLUTION NO. 07-016.

WHEREAS, Republic Act No. 9184, otherwise known as the **Government Procurement Reform Act, authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others;**

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act saw no need to seek authority from the City Council prior to entering into a contract;

WHEREAS, pursuant to Section 76 of RA 9184 states that, "any other law, presidential decree or issuance, executive order, letter of instruction, administrative order, proclamation, charter, rule or regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, however, to further enhance transparency and accountability the **Hon. City Mayor Aldrin L. San Pedro submitted to the City Council the construction agreement for ratification;**

WHEREAS, on **September 3, 2007**, the Sangguniang Panlungsod approved **Resolution No. 07-016**, entitled, "a resolution authorizing the City Mayor Hon. Aldrin L. San Pedro to secure or obtain a loan in the amount of One Billion Five Hundred Million Pesos (Php1,500,000,000.00);

WHEREAS, based on the reports and documents submitted by the City Mayor to the Sangguniang Panlungsod the said project has undergone due process for procurement and contracting for infrastructure project pursuant to RA 9184;

WHEREAS, on September 21, 2007, the City Government of Muntinlupa entered into a Construction Agreement with **SOCOR CONSTRUCTION CORPORATION** for the construction of the project amounting to One Hundred Twenty Nine Million Nine Hundred Fifty Four Thousand Four Hundred Fifty Nine Pesos and 76/100 (Php129,954,459.76), as a result of a public bidding held on September 17, 2007;

WHEREAS, the amount appropriated for the said project shall be taken from the approved One Billion Five Hundred Million Pesos (Php1,500,000,000.00) stand-by loan as stated in **Resolution No. 07-16**;

WHEREAS, the **Approved Agency Estimate (AAE)** of the contract for the project is One Hundred Thirty Million Two Hundred Ten Thousand Nine Hundred Ninety Three Pesos and 45/100 (**P130,210,993.45**);

WHEREAS, the project was awarded to **SOCOR CONSTRUCTION CORPORATION**, who being the **only bidder** for the project, Supply and Delivery of Asphalt and Ready Mix Concrete, at National Road from Alabang to Tunasan, Muntinlupa City;

WHEREAS, the contract implementation covers a period of 45 calendar days from the date the contractor receive the written Notice to Proceed;

WHEREAS, the Bids and Awards Committee (BAC) evaluated the Bids submitted in the public bidding held last September 17, 2007, where there was **only one** pre-qualified bidders;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod of Muntinlupa to authorize the **City Mayor Hon. Aldrin L. San Pedro**, to represent the City Government of Muntinlupa, to enter into a Construction Agreement with **SOCOR Construction Corporation**, for the project, Supply and Delivery of Asphalt and Ready Mix Concrete, at National Road from Alabang to Tunasan, Muntinlupa City in the amount of One Hundred Twenty Nine Million Nine Hundred Fifty Four Thousand Four Hundred Fifty Nine Pesos and 76/100 (Php129,954,459.76) which amount shall be taken from the approved One Billion Five Hundred Million Pesos stand-by loan as stated in Resolution No. 07-016.
