WHEREAS, Article 99 (iv), of the Local Government Code of 1991, Implementing Rules and Regulations, provides that, the Sangguniang Panlungsod as legislative body of the city, shall approve ordinances and pass resolutions necessary for an efficient and effective city government, and relative thereto, shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and the aftermath of said disasters or calamities and their return to productive livelihood following said events;

WHEREAS, Section 5 (a) of Rules and Regulations implementing Republic Act 8185 states that, "allocation- the 5% calamity fund shall be set aside as annual lump sum appropriation for every calendar year in the annual budget of the local government unit to be allocated to areas affected by the disaster or calamity. Local Government Units may also allocated for the use of a portion of the 5% calamity fund to other affected areas on condition that the said areas are declared as in state of calamity by the Sangguniang Panlungsod";

WHEREAS, due to the successive typhoons, "Lando, Mina and Nonoy", the city of Muntinlupa has been experiencing continuous rainfall that causes the sudden rise of the water level in Laguna De Bay and have caused damaged to roads;

WHEREAS, due to continuous heavy rains have caused flooding on the lakesides, shorelines, creek sides, and other low lying areas effected the communities settling along the lakeside from Barangay Tunasan to Barangay Sucat:

WHEREAS, on 29th day of November 2007, the Muntinlupa City Disaster Coordinating Council (MCDCC) approved Resolution No. 2007-01, entitled, "a resolution to request the Sangguniang Panlungsod of Muntinlupa to declare several communities living along the lakesides, shorelines of Muntinlupa in eight (8) barangay's from Barangay Sucat to Barangay Tunasan and other flooded prone areas in Muntinlupa City under the state of calamity due to the present flooding";

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, declaring the lakesides, shorelines, creek sides and other low-lying areas from Tunasan to Sucat, Muntinlupa City to be under a State of Calamity.
