WHEREAS, it is a declared policy of the State to give priority for the needs of the xxx elderly xxx, and in consonance with the said constitutional principles is to motivate and encourage the senior citizens to contribute to nation building;

WHEREAS, the Office of the Senior Citizens' Affairs of the City of Muntinlupa was created thru Kautusang Bayan 93-25 by then Sangguniang Bayan last March 15, 1993, in compliance with the provisions of Republic Act No. 7432, "An Act to maximize the contribution of senior citizens to nation building, grant benefits and special privileges and for other purposes";

WHEREAS, Republic Act 7432 aims to establish mechanisms whereby the contribution of the senior citizens are maximized; to adopt measures whereby senior citizens are assisted and appreciated by the community as a whole; and to establish a program beneficial to the senior citizens, their families and the rest of the community that they serve;

WHEREAS, a letter dated 5 January, 2007 was sent by Ms. Maricel L. Dacuycuy, Officer-In-Charge of OSCA, requesting the Sangguniang Panlungsod for the continuation of Ordinance No. 06-083 requiring all cinema owners and operators in Muntinlupa City to increase their theater admission fees by One Peso (P1.00) covering the period from February 1 to December 31, 2007 to support the **Project:** "HANDOG KALINGA", which is intended to provide medical assistance for the senior citizens' of the City, specifically, the Federation of Senior Citizens' Association of the Philippines (FSCAP)-Muntinlupa Chapter, whose membership now totaling to 27,000;

WHEREAS, during a public hearing conducted by the Committee on Games and Amusement last January 17, 2007, Mr. Lito Flores, Officer-In-Charge of Alabang Town Center granted the request of Ms. Maricel Dacuycuy, Officer-In-Charge of OSCA provided that no other agencies, like Boy Scouts of the Philippines and Red Cross of the Philippines will be allowed to apply based on the same request. Moreover, the Alabang Town Center will not increase its theater admission fees to P1.00, instead it will deduct P1.00 per theater admission fee collected;

WHEREAS, except for Alabang Town Center, other cinema owners and operators in Muntinlupa City are requested to increase their theater admission fees by One Peso (P1.00) covering the period from February 1 to December 31, 2007.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod to request all cinema owners/operators operating within the City of Muntinlupa to allocate One Peso (P1.00) of their movie tickets covering the period from February 1 to December 31, 2007 as contribution to the Federation of Senior Citizens' Association of the Philippines (FSCAP)- Muntinlupa Chapter.

RESOLVED FURTHER, that a copy of this Resolution shall be posted in every cashier's booth of the cinemas to inform the moviegoers about the contents of the same.
