WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that "no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian";

WHEREAS, the *City Government* has been leasing the *Doña Zoila Building* located at *National Road, Putatan, Muntinlupa City* for the use of the City Prosecutors' Office with *Mrs. Conchita Recaido*;

WHEREAS, the contract of lease between the City Government and *Mrs. Conchita Recaido* expired last *December 31,2006*, subject to extension of two years on mutual agreement of both parties;

WHEREAS, the Contract of Lease is hereby renewed/extended for another two years from January 1, 2007 to December 31, 2009, in the amount of Sixty Five Thousand Pesos (P65,000.00) per month and with an increase of 12% per annum;

WHEREAS, the monthly rental from January 1, 2007 to December 31, 2009, shall be Sixty Five Thousand Pesos (P65,000.00) plus 12% vat to be paid by the City Government to the lessor on or before the first day of the month:
