**WHEREAS**, Ospital ng Muntinlupa Oversight Committee passed Resolution No. 04-2006 dated October 25, 2006;

**WHEREAS**, the Ospital ng Muntinlupa is presently maintaining a savings account with the Development Bank of the Philippines as its depository bank;

**WHEREAS**, the Ospital ng Muntinlupa, through its Hospital Director, has received an offer from the Philippine Veterans Bank for Payroll Servicing Via Automated Teller Machines (ATM), together with the installation of an ATM inside the hospital, premises to afford easy access to cash of employees and patients at no cost whatsoever to the hospital;

**WHEREAS**, the Philippine Veterans Bank is also proposing a Deposit Pick-up Agreement with the hospital for its cash and/or other deposit items through an armored car or service vehicle;
