WHEREAS, Dra. Nelia A. Barlis, City Treasurer of the City of Muntinlupa, was born on December 16, 1952 in Poblacion, Muntinlupa City to Luis G. Argana (deceased) and Felicitas Abdusan- Dugayo, and married to Danilo F. Barlis;

WHEREAS, Dra. Barlis finished her Bachelor of Science in Commerce, major in Management at Philippine College of Commerce in 1976, and earned her Doctor of Education, School Administration and Supervision in Perpetual Help of Laguna 2003;

WHEREAS, Dra. Nelia A. Barlis started her public service as an office clerk in 1973-1975, as journal clerk in 1975-1978, as bookkeeper in 1978-1980, as accountant in 1981-1988, as Accountant IV in 1989-1991, as Assistant Municipal Treasurer in 1991-1994, as Officer-in-Charge, Municipal Treasurer in 1994-1995 at the then Municipality of Muntinlupa; and now as a City, she was appointed as Officer-in-Charge, City Treasurer in 1995-1996, and as full pledged City Treasurer in 1996-to present;

WHEREAS, Dra. Nelia A. Barlis' major achievements were: the increase of collection from P226,533,675.74 in 1996 to P1,517,714,069.80 in 2006 by employing strategies and plan of action; bring the office closer to the people from 1994 up to the present by deploying representatives to issue community tax certificate to factories, schools, business establishments and government offices, and satellite collection unit is sent quarterly to subdivisions to collect real property taxes; computerized the Real Property Tax and Business Tax Division and the computerization of the check issuances;

**WHEREAS**, her membership in professional and civic organizations are the: Philippine Association of Local Assessors and Treasurer, Inc. as Treasurer; one of the Executive Officer of the Assessors and Treasurer's Association of Metro Manila; Muntinlupa Employees Savings and Loan Association, Inc. as Chairman; Southernside Montessori School., as President; and New Sinai MDI Hospital, Sta. Rosa, Laguna as Director;

**WHEREAS**, her brilliance as a public servant was recognized by the Bureau of Local Government Finance thus she was appointed as Officer-in- Charge Treasurer of the premier and financial capital city of the Philippines, City of Makati on September 8, 2005 until the present;

**WHEREAS**, as concurrent City Treasurer of Makati, **Dra. Barlis** has impressed upon the locals of Makati that a Muntinlupeno can make a difference in whatever field one chooses when armed with principle and dedication to work, thus her permanency was requested by the premier city of Makati to which she acceded;






