A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ATTY JAIME R. FRESNEDI TO ENTER INTO A NEW CONTRACT IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH REN TRANSPORT CORPORATION IN GARBAGE COLLECTION AND DISPOSAL SERVICES FOR THE YEAR 2007 IN THE AMOUNT OF EIGHT MILLION EIGHTY THREE THOUSAND, THREE HUNDERD THIRTY THREE PESOS AND EIGHT CENTAVOS (Php8,083,333.08) PER MONTH OR A TOTAL CONTRACT PRICE OF NINETY SIX MILLION, NINE HUNDRED NINETY NINE THOUSAND NINE HUNDRED NINETY SEVEN PESOS (Php96,999,997.00) FOR ONE (1) YEAR

WHEREAS, the City of Muntinlupa advertised the *Invitation to Apply for Eligibility and to Bid of the Contract for Garbage Collection and Disposal Service of the City of Muntinlupa for 2007*. in two (2) newspapers of national circulation and posted the same in the G-EPS and in conspicuous place at the premises of the City Hall of Muntinlupa continuously for seven (7) days;

WHEREAS, the public bidding for garbage collection and disposal services was conducted last January 10, 2007;

WHEREAS, in response to said advertisement, only one (1) prospective bidder submitted an *Application For Eligibility*, was declared eligible, and whose technical and financial proposal, opened on the same day on January 10, 2007 passed the preliminary examination of bids;

WHEREAS, upon post qualification and careful examination, evaluation and verification of the eligibility, technical and financial requirements submitted by the lone bidder with the single calculated bid, the same was found to be responsive;

WHEREAS, the contract shall be effective for a period of one (1) year from the signing hereof;

WHEREAS the approved budget for the contract is Ninety Six Million Nine Hundred Ninety Nine Thousand Nine Hundred Ninety Seven Pesos (Php96,999,997.00);

WHEREAS, there is a budget appropriated for Garbage Collection and Disposal Services amounting to *Ninety Six Million Nine Hundred Ninety Nine Thousand Nine Hundred Ninety Seven Pesos (Php96,999.997) under the 2007 Executive Budget*.

NOW THEREFORE, BE IT RESOLVE AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa, to authorize the Hon. City Mayor Atty. Jaime R. Fresnedi to enter into a new contract in behalf of the City Government of Muntinlupa with REN Transport Corporation in garbage collection and disposal services for 2007 in the amount of Eight Million Eighty Three Thousand, Three Hundred Thirty Three Pesos and Eight Centavos (Php8,083,333.08) per month or the total contract price of Ninety Six Million Nine Hundred Ninety Nine Thousand Nine Hundred Ninety Seven Pesos (Php96,999,997.00)
