WHEREAS, a Multi Partite Memorandum of Agreement between and among the Department of Environment and Natural Resources (DENR), the Metro Manila Development Authority (MMDA), the Department of Public Works and Highways (DPWH), the Philippine National-NCR and the Philippine Army on August 19, 2006;

WHEREAS, the agreement was entered into by the aforementioned agencies to protect the environment by involving not only the government but also different stakeholders in greening and transforming the country into a healthy environment;

WHEREAS, the City of Muntinlupa puts a premium on environment protection as one of its priority program for development and hereby expresses its support to the said agreement by implementing a massive tree planting project dubbed as "Green Philippine Highways" in the city, particularly at a portion of the Sunken Garden in the New Bilibid Prison Reservation which is hereby declared a "Mini - Forest Park" for this purpose;
