TAVU CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF SUCAT HEALTH CENTER LOCATED AT SUCAT, MUNTINLUPA CITY IN THE AMOUNT OF FOUR MILLION SEVEN HUNDRED THIRTY SEVEN THOUSAND SEVEN HUNDRED THIRTY THREE PESOS AND 63/100 (P4,737,733.63) TO BE TAKEN FROM THE 2007 EXECUTIVE BUDGET UNDER INFRASTRUCTURE PROJECTS.

WHEREAS, the City Administrator, Atty. Henry A. Reyes, endorsed to the Sangguniang Panglungsod the **Construction of Sucat Health Center** amounting to **Four Million Seven Hundred Thirty Seven Thousand, Seven Hundred Thirty Three Pesos and Sixty Three Centavos (P4,737,733.63)**

WHEREAS, the construction of **Sucat Health Center** located at Sucat Muntinlupa City was awarded to **C.C. Tavu Construction**;

WHEREAS, the City Government of Muntinlupa posted the invitation to bid last January 6, 2007 the Eligibility Screening was January 22, 2007, the opening of bid was February 12, 2007 and the Notice of Award was February 26, 2007;

WHEREAS, The **Approved Agency Estimate (AAE)** is **Four Million Seven Hundred Fifty Thousand Pesos (Php4,750,000.00)**;

WHEREAS, The Budget Office certifies that there is an available fund for said project and it has an **Obligation Request No. 100-0702-01803** in the amount of **Four Million Seven Hundred Forty Two Thousand Three Hundred Sixty Pesos and 96/100 (Php4,742,360.96)**;

WHEREAS, there is available fund for the said project and shall be taken from 2007 Executive Budget under infrastructure Project.

WHEREAS, the project duration is **One Hundred Twenty Days (120)** equivalent to four (4) months;
