FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT TO ENTER AND SIGN INTO A CONSTRUCTION AGREEMENT WITH DEMAR CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF COVERED COURT LOCATED AT BRUGER ST., PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF THREE MILLION FOUR HUNDRED THIRTY NINE THOUSAND THREE HUNDRED SIXTY THREE PESOS AND 50/100 (P3,439,363.50) TO BE TAKEN FROM THE 2007 EXECUTIVE BUDGET UNDER INFRASTRUCTURE PROJECTS.

WHEREAS, the City Administrator, Atty. Henry A. Reyes, endorsed to the Sangguniang Panglungsod the **Construction of Covered Court at Brugger St. Putatan Muntinlupa City** amounting to **Three Million Four Hundred Thirty Nine Thousand, Three Hundred Sixty Three Pesos and Sixty Fifty Centavos (P3,439,363.50)**

WHEREAS, the construction of **Covered Court** located at Brugger St. Putatan Muntinlupa City was awarded to **Demar Construction**;

WHEREAS, the City Government of Muntinlupa posted the invitation to bid last January 6, 2007 the Eligibility Screening was January 22, 2007, the opening of bid was February 12, 2007 and the Notice of Award was February 26, 2007;

WHEREAS, The **Approved Agency Estimate (AAE)** is **Three Million Five Hundred Thousand Pesos (Php3,500,000.00)**;

WHEREAS, The Budget Office certifies that there is an available fund for said project and it has an **Obligation Request No. 100-0701-00785** in the amount of **Three Million Four Hundred Forty Six Thousand One Hundred Fifty Five Pesos and 67/100 (Php3,446,155.67)**;

WHEREAS, there is available fund for the said project and shall be taken from 2007 Executive Budget under infrastructure Project.

WHEREAS, the project duration is **One Hundred Twenty Days (120)** equivalent to four (4) months;
