FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT TO ENTER AND SIGN INTO A CONSTRUCTION AGREEMENT WITH DEMAR CONSTRUCTION FOR THE PROJECT ROAD CONCRETING AT CROSSLEY LANE LOCATED AT LIBERTY HOMES, CUPANG, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION TWO HUNDRED EIGHTY EIGHT THOUSAND SEVEN HUNDRED FIFTEEN PESOS, (P1,288,715.00) TO BE TAKEN FROM THE 2007 EXECUTIVE BUDGET UNDER INFRASTRUCTURE PROJECTS.

WHEREAS, the City Government of Muntinlupa posted the invitation to bid last January 6, 2007 the Eligibility Screening was January 22, 2007, the opening of bid was February 12, 2007 and the Notice of Award was February 26, 2007;
