CERVANTES CONSTRUCTION FOR THE PROJECT ROAD CONCRETING AND DRAINAGE SYSTEM LOCATED AT BAYANAN BAYWALK, BAYANAN, MUNTINLUPA CITY IN THE AMOUNT OF SIXTEEN MILLION NINE HUNDRED FIFTY ONE THOUSAND SEVEN HUNDRED SIXTY NINE PESOS AND 92/100 (P16,951,769.92) TO BE TAKEN FROM THE 2007 EXECUTIVE BUDGET UNDER INFRASTRUCTURE PROJECTS.

Reyes, endorsed to the Sangguniang Panlungsod the Construction Agreement regarding the project **Construction of Road Concreting and Drainage System located at Bayanan, Muntinlupa City** amounting to **Sixteen Million Nine Hundred Fifty One Thousand Seven Hundred Sixty Nine and 92/100 (P16,951,769.92)**

**WHEREAS**, that the **Road Concreting and Drainage System at Baywalk, Bayanan, Muntinlupa City** was awarded to **D.L. Cervantes Construction**;

**WHEREAS**, the City Government of Muntinlupa posted the invitation to bid last January 6, 2007 the Eligibility Screening was January 22, 2007, the opening of bid was February 12, 2007 and the issuance Notice of Award was February 26, 2007;

**WHEREAS**, The **Approved Agency Estimate (AAE)** is **Seventeen Million Pesos (Php 17, 000,000.00)**;

**WHEREAS**, The Budget Office certifies that there is an available fund for said project and it has an **Obligation Request No. 100-0701-00933** in the amount of **Sixteen Million Nine Hundred Ninety Nine Thousand Nine Hundred Fifty Eight Pesos and 62/100 ( (Php16,999,958.62)**;

**WHEREAS**, there is available fund for the said project and shall be taken from 2007 Executive Budget under infrastructure Project.

**WHEREAS**, the project duration is **One Hundred Twenty Days (120)** equivalent to four (4) months;
