A RESOLUTION AUTHORIZING THE HON. MAYOR ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT TO ENTER AND SIGN INTO A CONSTRUCTION AGREEMENT WITH D.L. CERVANTES CONSTRUCTION FOR THE PROJECT ROAD CONCRETING AND REPAIR LOCATED AT SUSANA HEIGHTS, TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF FOURTEEN MILLION NINE HUNDRED SIXTY THOUSAND EIGHT HUNDRED THREE PESOS AND 88/100 (P14,960,803.88) TO BE TAKEN FROM THE 2007 EXECUTIVE BUDGET UNDER INFRASTRUCTURE PROJECTS.

WHEREAS, the City Administrator, Atty. Henry A. Reyes, endorsed to the Sangguniang Panlungsod the Construction Agreement regarding the project **Road Concreting and Repair located at Susana Heights, Tunasan, Muntinlupa City** amounting to **Fourteen Million Nine Hundred Sixty Thousand Eight Hundred Three and 88/100 (P14,960,803.88)**;

WHEREAS, that the road concreting and and repair at **Susana Heights, Tunasan, Muntinlupa City** was awarded to **D.L. Cervantes Construction**;

WHEREAS, the City Government of Muntinlupa posted the invitation to bid last January 6, 2007 the Eligibility Screening was January 22, 2007, the opening of bid was February 12, 2007 and the issuance Notice of Award was February 26, 2007;

WHEREAS, The **Approved Agency Estimate (AAE)** is **Fifteen Million Pesos (Php 15, 000,000.00)**;

WHEREAS, The Budget Office certifies that there is an available fund for said project and it has an **Obligation Request No. 100-0702-01884** in the amount of **Fourteen Million Nine Hundred Eighty Seven Thousand Six Hundred Fifty and 83/100 (P14,987,650.83)**;

WHEREAS, there is available fund for the said project and shall be taken from 2007 Executive Budget under infrastructure Project.

WHEREAS, the project duration is **One Hundred Twenty Days (120)** equivalent to four (4) months;






