FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT TO ENTER AND SIGN INTO A CONSTRUCTION AGREEMENT WITH JBA ESPEJO CONSTRUCTION FOR THE PROJECT ROAD CONCRETING AND DRAINAGE SYSTEM LOCATED AT PUPA HOMES I, PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION FIVE HUNDRED SIXTEEN THOUSAND EIGHT HUNDRED SIXTY SEVEN PESOS AND 74/100 (P1,516,867.74) TO BE TAKEN FROM THE 2007 EXECUTIVE BUDGET UNDER INFRASTRUCTURE PROJECTS.

Reyes, endorsed to the Sangguniang Panglungsod the Construction Agreement regarding the project Construction of Road Concreting and Drainage System located at PUPA I, Putatan, Muntinlupa City amounting to *One Million Five Hundred Sixteen Thousand Eight Hundred Sixty Seven Pesos and 74/100 (P1,516,867.74)*;

**WHEREAS**, that the Road Concreting and Drainage System at PUPA I, Putatan, Muntinlupa City was awarded to JBA Espejo Construction;

**WHEREAS**, the City Government of Muntinlupa posted the invitation to bid last January 6, 2007 the Eligibility Screening was January 22, 2007, the opening of bid was February 12, 2007 and the issuance Notice of Award was February 26, 2007;

**WHEREAS**, The Approved Agency Estimate (AAE) is *One Million Five Hundred Twenty Three Thousand One Hundred Fifty Pesos and 12/100 (Php 1, 523,150.12)*;

**WHEREAS**, The Budget Office certifies that there is an available fund for said project and it has an **Obligation Request No. 100-0701-00781** in the amount of *One Million Five Hundred Twenty Three Thousand One Hundred Fifty Pesos and 12/100 (Php 1, 523,150.12)*;

**WHEREAS**, there is available fund for the said project and shall be taken from 2007 Executive Budget under infrastructure Project.

**WHEREAS**, the project duration is **One Hundred Twenty (120) Days** equivalent to four (4) months;
