WHEREAS, the contractor has agreed and accepted the award to undertake the construction work for the Project for the city government in conformance with the plans and specification stated in the Work Program;


WHEREAS, the Contractor shall furnish all labor, materials, equipment and supplies and the performance of all operation necessary for the complete construction of the project;
