A RESOLUTION SUSPENDING INDEFINITELY THE IMPLEMENTATION AND ENFORCEMENT OF ORDINANCE NO. 07-017, AN ORDINANCE REQUIRING OWNERS, OPERATORS, LESSEES, CONTRACTORS AND DEVELOPERS AND PERSONS REQUIRED TO SECURE BUSINESS AND/OR BUILDING PERMIT IN DOING BUSINESS OR UNDERTAKING CONSTRUCTION OR REPAIR WORK IN MUNTINLUPA CITY TO SECURE PUBLIC LIABILITY INSURANCE.

WHEREAS, the City Council *passed Ordinance No. 07-17* on November 19, 2007, requiring owners, operators, lessees, contractors and developers and persons required to secure business and/or building permit in doing business or undertaking construction or repair work in Muntinlupa City to secure Public Liability Insurance;

WHEREAS, investors and other business establishments doing business in the City have *requested the suspension* of the implementation and enforcement of this ordinance to relieve them of paying additional expenses in securing Insurance before securing business permits;

WHEREAS, it is the policy of the City Government of Muntinlupa to attract more investors in the City in order to gain more employment opportunities to its inhabitants who have no jobs and to raise more revenues for the City;

WHEREAS, the Hon. City Mayor, through a letter signed by the City Administrator, requests the City Council to pass a resolution suspending the implementation and enforcement of Ordinance No. 07-017 for one year from January 18, 2008;




