WHEREAS, Article 99 (iv), of the Local Government Code of 1991, Implementing Rules and Regulations, provides that, "the Sangguniang Panlungsod as legislative body of the city, shall approve ordinances and pass resolutions necessary for an efficient and effective city government, and relative thereto, shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and the aftermath of said disasters or calamities and their return to productive livelihood following said events";

WHEREAS, on January 14, 2008 six (6) homeowners whose houses were totally damaged, three (3) house sharers whose houses were totally damaged, one (1) house owner whose house was partially damaged, three (3) house sharers whose houses were partially damaged and three (3) house renters were affected by the fire in *Purok 4, PNR Site, Sucat, Muntinlupa City*;

WHEREAS, the Social Services Department (SSD) recommended to declare the affected area as in <u>a state of calamity</u>;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the members of the 5<sup>th</sup> Sangguniang Panlungsod, to declare the area affected by the fire on **January 14, 2008**, at Purok 4, PNR Site, Sucat, Muntinlupa, as in a **state of calamity**.
