WHEREAS, Intermed Marketing Phils., Inc. has already secured a certificate of Board Resolution # 06-410, dated September 12, 2006 approving the grant of a pre-qualification clearance for the declaration of its building as Info Tech (IT) building;

WHEREAS, under **PEZA Board Resolution No. 00-411** dated December 29, 2000, Prescribing for the Guidelines of the Registration of Information Technology Enterprises and the Establishment and Operation of IT Parks / Buildings, it is stated in letter A No. VI that one of the requirement for PEZA consideration and issuance of a Presidential Proclamation is the endorsement by the City council;

WHEREAS, Intermed Marketing Phils., Inc. being the owner of "**The Paragon Corporate Center**" building shall not be entitled to any incentive and is committed to pay its regular taxes to the city government of Muntinlupa;

WHEREAS, the passage of this resolution, for whatever causes or reasons, shall not cause the reduction of taxes it has to pay to the City Gcvernment of Muntinlupa and shall not cause additional incentives;
