WHEREAS, the land area is seven thousand one hundred eighty nine square meters (7,189) portion of local government property in Alabang, Muntinlupa City;

WHEREAS, by virtue of the foregoing, all improvements in the Alabang Flea Market area now belongs to the City Government by the expressed provisions of the contract between the parties;

WHEREAS, the Alabang Flea Market area is vital to the development of the Central Business District of Barangay Alabang, therefore, its development is imperative;

WHEREAS, the City Government of Muntinlupa in its desire to provide highly efficient delivery of basic services in the area will have to utilize the Alabang Flea Market area in order to provide the same;

WHEREAS, the City Government of Muntinlupa in order to achieve its objective shall formulate a mixed – used development plan for the area to be carried out by the City Mayor of Muntinlupa;

WHEREAS, this authority applies to all sub-lessees, tenants, persons, all occupants of the place working for or in behalf and deriving benefits from Alabang Flea Market;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod of Muntinlupa to authorize the City Mayor to take over the Alabang Flea Market area in accordance with law and/or to go
